What is the overall <u>deductible</u>?	\$750 person/ \$1,500 family per calendar year.	Generally, you must pay all the costs from <u>providers</u> up to the <u>deductible</u> amount before this <u>plan</u> begins to pay. If you have other family members on the <u>plan</u> , each family member must meet their own individual <u>deductible</u> until the total amount of <u>deductible</u> expenses paid by all family members meets the overall family <u>deductible</u> .
Are there services covered before you meet your <u>deductible</u>?	Yes. Well-child care, in- <u>network</u> <u>preventive care</u> , in- <u>network</u> <u>urgent care</u> services, in- <u>network</u> independent labs, in- <u>network</u> office services, in- <u>network</u> prosthetic limbs, colonoscopies, mammograms and <u>prescription drugs</u> are covered before you meet your <u>deductible</u> .	This <u>plan</u> covers some items and services even if you haven't yet met the <u>deductible</u> amount. But a <u>copayment</u> or <u>coinsurance</u> may apply. The In- <u>Network</u> health and drug card <u>out-of-pocket</u> maximum amounts accumulate together.	The <u>out-of-pocket limit</u> is the most you could pay in a year for covered services. If you have other family members in this <u>plan</u> , they have to meet their own <u>out-of-pocket limits</u> until the overall family <u>out-of-pocket limit</u> has been met.

Does this plan provide Minimum Essential Coverage? Yes

If you are eligible for certain types of Minimum Essential Coverage, you may not be eligible for the premium tax credit.
